Standing Rules

1. All Members must have their current membership in their possession when on club property.
2. Members have the right and are required to check other member's cards while on club grounds.
3. Ranges are open from 8 AM. To Sunset. (Sunset time varies with calendar)
4. Shooting any form of wildlife on club property is strictly prohibited.
5. Shooting of rocks, glass, bowling pins, concrete or any object that may promote a ricochet. (Metal free swing targets are permitted with lead bullets only)
6. All casings, targets, cans, and other trash are to put in cans provided before you leave.
7. Eye and ear protection are required while shooting on any range. This rule applies to non-shooters, such as guests and children, as well. Allowing a child to run loose on any range will result in expulsion from the club.
8. Firearms must be under control at all times. NO uncontrolled, sustained or rapid fire will be tolerated. (AIM EVERY SHOT) Be aware of every other shooter's position on the range with you.
9. NO ALCOHOL OR RECREATIONAL DRUGS ALLOWED ON THE RANGE.
10. NO aerial targets period. Biodegradable clays may be used as still targets only.
11. Only Legal firearms permitted on the property.
12. The firing line is considered to be the front of the benches. NO ONE is allowed beyond this point when range is active.
13. Targets must be placed at the base of the earthen backstops. No targets are to be placed above center of the earthen back stops. ABSOLUTELY NO target set mid range.
14. No person is to be down range unless the range is safe. All shooting stops and actions open, clips out, all guns down on bench. No handling guns while anyone is setting, checking or retrieving target. Each shooter must deem, " IS THE LINE SAFE," before going beyond the firing line.
15. Ranges may close for short maintenance periods. We generally only close the range we are working on at that moment.
16. No one under age 18 is permitted to use the range without parent or guardian with them on the range.
17. All NRA safe firearm practices will be observed while on the range.

Definition of Family membership: This means that you, (dues paid and current), your spouse and all children under age (18) are included on one card. This means that you, the registered member, must be with them when they are on club property. This does not apply to supervised events open to the general public.

Definition of Guest Policy: You may bring guests to the club. Guests must be accompanied by you, the member. Any misdeed incurred by your guest will be your responsibility. You will be held accountable and your membership is at risk of expulsion. Each guest is \$5.00 ea. per sign-in.
